

# **Story Point Poker Terms Of Service**

**IMPORTANT**: BY CREATING AN ACCOUNT OR BY UTILIZING THE STORY POINT POKER SERVICE YOU AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS.

Please review these Terms and Conditions carefully before using our Service.

### **Terms of Service**

The Terms of Service constitutes a contract between Agile Brains ApS and you. By using the Service, you acknowledge, accept and agree with all provisions of the "Terms of Service" and our "Privacy Policy".

If you do not agree to these Terms, you do not have the right to access or use our Service.

### **Service Definition**

Story Point Poker (referred to as the Service) is a tool with the purpose to help facilitate planning poker estimation sessions.

## **Account Obligations**

When you register for an account you sign up to the a 30 days free trial of the "Business" plan.

- You must provide true, accurate, current and complete information about Yourself and the company you represent as prompted by the registration form, and maintain and promptly update the registration data to keep it true, accurate, current and complete. We assume no duty to verify such information. If You provide any information that is untrue, inaccurate, not current or incomplete we have the right to suspend or terminate your account.
- You are responsible for protecting the password and for all activities that occur
  under your account. You should notify Story Point Poker immediately if you become
  aware of any breach of security or unauthorized use of your account.
- Our Service is not intended for use by persons under the age of 13. By using the Service you are representing to us that you are over the age of 13.

## **Pricing Plans**

#### **Basic Plan**

The "Basic" plan is a free offer for smaller teams with a basic need.

• Minimum set of features to complete a planning poker game using the original Scrum planning poker card deck.

The basic plan comes with some limitations.

- Rooms are only intended to be used once and are not open for reusability over time. Rooms have a retention period of 7 days and will be disabled for anonymous access after that. Access can be regained by a registered user. (see "Business" plan)
- The card deck is restricted to the Scrum Scale, but the individual cards can be enabled and disabled.
- There is a maximum of 7 participants.

The "Basic" plan is free of charge and requires no registered account.

#### **Business Plan**

The "Business" plan increases your moderator powers.

- All rooms you moderate automatically becomes reusable so that the unique room link remains and can be used in calendar invites etc. All other participants can remain anonymous users and still access the room.
- Scrum. Fibonacci. Power Of Two and T-Shirt Card Decks are available.
- You will have the ability to kick other player from a room.
- A list of recently joined rooms will be available for easy access.
- Unlimited participants.

The Business plan is a paid B2B offer and cannot be used as a private consumer. The "Business" plan requires a registered account. (see "Account Obligations)

#### **Enterprise Plan**

Enterprise offers the same features and have the same obligations as the "Business" plan. The only difference is that you pay for a whole organization instead of a single user.

# **Billing and Refunds**

#### Billing

Paid plans are monthly recurring subscriptions and will be charged up front to the provided credit card.

The subscription can be terminated from within the app at any time and will have effect at the end of the current billing period.

#### Refunds

If you are not satisfied with your subscription, we offer a full refund within the first 14 days of the first purchase. Please inform us within the first 14 days if you would like a refund. We do not offer refunds after the first 14 days.

### **Proper Use**
